Overview:

This list includes articles from the following journals: *Allahabad Law Journal* (1904-47), *Bombay Law Journal* (1923-46), *Bombay Law Reporter* (journal section) (1900-47), *Criminal Law Journal of India* (1904-44), *Madras Law Journal* (1891-1947) and *Travancore Law Journal* (1911-44). Because these lists were compiled using incomplete library collections, there are occasional gaps within these date spans. Each journal section below begins with a detailed list of years and volumes covered.
